

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to 435 New Haven Ave, and Hochman Chiropractic/Accident Injury Therapy Ctr and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Hochman Chiropractic/Accident Injury Therapy Ctr include 435 New Haven Ave and accidentinjurytherapy.com. The Hochman Chiropractic/Accident Injury Therapy Ctr website is a news and information site. By using the Hochman Chiropractic/Accident Injury Therapy Ctr website, you consent to the data practices described in this statement.

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

Sharing Information with Third Parties

Hochman Chiropractic/Accident Injury Therapy Ctr does not sell, rent or lease its customer lists to third parties.

Automatically Collected Information
